6. The recommendations of the scrutiny committee were placed before the Governing Council and vide decision read (5) above, the Governing Council resolved to grant Conditional Continuation of Provisional Affiliation 2025-26 to Ashtangam Ayurveda Chikitsalayam and Vidhyapeedham, Palakkad for conducting BAMS course (60 Seats) for the AY 2025-26, subject to the receipt of Letter of Permission from the NCISM, Govt. of India, Ministry of AYUSH.

6. Vide paper read (6) above, the Medical Assessment and Rating Board for the Indian System of Medicine (NCISM), Ministry of AYUSH, Govt. of India has granted extended permission to Ashtangam Ayurveda Chikitsalayam and Vidhyapeedham, Palakkad with an intake capacity with **60 seats In UG (BAMS) course** in accordance with Regulation 54 (3) of MBSAR UG Ayurveda 2024 for the academic session 2025-26, under section 28 of NCISM Act, 2020.

7. The Honble Vice Chancellor has granted Continuation of Provisional Affiliation to the college, for the academic year 2025-26. Accordingly, orders are hereby issued **granting Continuation of Provisional Affiliation to Ashtangam Ayurveda Chikitsalayam and Vidhyapeedham, Palakkad for conducting UG (BAMS) course with 60 seats for the academic year 2025-26.**

8. The college shall strictly adhere to the following conditions detailed below :-

i) The college shall strictly comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG-BAMS course during 2025-26 vide letter read (6) above.

ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulation of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

iii) in the light of the direction of the Honble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

iv) Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

v) The college should remit balance annual administration fee fixed for UG - BAMS course for the academic year 2025-26, if applicable.

vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
